Mark and Rick:

Today, May 12, 2015, at approximately 2:00PM, WES Industries, Inc. was performing maintenance work on the leachate forcemain from the landfill to the wastewater lift station on Knights Trail. This work includes re-installing air release valves (ARVs) along the forcemain to improve forcemain operations. While performing work on ARV #7, approximate location shown on the attached drawings, the piping for the valve assembly failed and leachate was released on to the soils surrounding the ARV. WES immediately closed a shutoff valve at the tap for the ARV and contained the leachate as quickly as possible. WES is currently in the process removing all soil contaminated with leachate from the area, they plan to cover the soil tonight with tarps, then tomorrow transport the soil to the landfill for disposal. The area will then be backfilled with clean soil. We will document the cleanup activities and provide a final completion report as soon as possible.

Please also accept this email as a courtesy notification of the maintenance work being performed beginning on May 1, 2015. Per an email provided by Cory Dilmore at FDEP Tallahassee (see attached), this work (listed as the #2 in the list of work in the email), and several other work items, was determined to be exempted from permitting. However, Cory requested that we notify the South District and Tallahassee when the work commenced. I apologize for the oversight in not providing notification of the work sooner. I plan to send a formal courtesy notification to you and Tallahassee FDEP tomorrow as well as ensure we provide notification for the other work items listed when they commence.




