# **COMMENTS:**

### 10/15/2015

The Department received an odor complaint on 10/8/15 regarding odors at J.E.D. landfill. The complainant has been in contact with Bob Walls and John Hartings periodically over the last few months regarding odors.

During the site inspection, no odors were detected at or around the landfill's property. Inspectors spoke with Dave Collins regarding operating practices at the landfill. The working face is being covered daily as required by permit conditions and state rules, and inspectors witnessed cover being delivered to the working face during the inspection. Inspectors also spoke with Dan Jansen, the facility's new Environmental Compliance Specialist. The facility has created an odor

management plan and has been using this plan to address odor complaints from Mr. Crawford, as well as monitor for odors on and off the property. In addition, the facility plans to purchase a new weather station. The inspectors requested that the plan be submitted to the Department for records.

Based on the findings during the inspection, J.E.D. landfill is in compliance with permit conditions and associated state rules regarding odors.
