Dear Mr. Marion:

The Department has completed its review of the following documentation submitted on your behalf by Neel-Schaffer, Inc.

- Construction Completion Certification Report North Cell Phase II Area 3, signed 11/6/2015. Mehran (Ron) S. Beladi, the Professional Engineer of Record, signed and sealed the "Certification of Completion of a Solid Waste Management Facility" form contained in the Report.
- North Cell Expansion Certification- LCS and LDS Cleaning, 11/13/2015 e-mail (Report about the cleaning and video inspection of the leachate collection system.)

The Department conducted two inspections during construction of the cell: 6/12/2015, and 11/6/2015. Based upon the review of the above submittals and certification by Mehran (Ron) S. Beladi, the Professional Engineer of Record, and the Department's inspections, the Department concurs that the facility has completed construction of North Cell Phase II Area 3 and that it is substantially consistent with plans and specifications approved in DEP Permit No. SC64-0078767-029.

As documented by the Department's letter dated 3/24/2015, the facility is in compliance with the financial assurance requirements. (This was based on the 65.65 acres authorized for disposal in the North Cell.) In its 6/2/2015 letter, the Department approved the detailed cost estimate dated 5/27/2015. That estimate included North Cell Phase II Area 3 (total of 77.85 acres). Because an escrow account is used, you will need to discuss with Susan Eldredge, FDEP Financial Coordinator, how to include the use of North Cell Phase II Area 3 in your next financial assurance mechanism update.

As of the date of this letter, North Cell Phase II Area 3 is hereby authorized to accept waste.
