The Department conducted two inspections during construction of the Phase II expansion area at the North Cell. The first one was on 6/12/2015. The bottom liner had been laid. The second was on 11/6/2015. The cell construction was complete; the final protective sand layer had been placed on the liners and leachate collection system. The method for ensuring 2-feet of sand had been placed was acceptable (that is, survey after base had been prepared; survey after sand had to be at least 2.1 feet higher). The leachate collection system was scheduled to be cleaned the week of 11/9/2015. During both inspections, no issues or deviations were observed.

Prior to the cell inspection on 11/6/2015, the Department met with the engineer of record. We reviewed the "as built" drawings and certification of construction report. All deviations were explained. We agreed they are minor and properly documented in the report.

In addition to inspecting the newly constructed cell, we looked at the landfill gas collection system well heads that were recently installed. The Department's approval of the construction certification package had been sent on 10/30/2015.

The landfill gas flare was operating. There were no visible emissions.
