- 1. The site plan submitted with the application was not signed and sealed by a licensed professional engineer, in accordance with Rule 62-701.320(6), F.A.C., and Part III.A of the application. Please provide a signed and sealed site plan to the Department.
- 2. Closing costs are approved in the amount of \$3,600.00. Proof of financial assurance for this facility in the name of the permit applicant must be provided and in place at the time of permit issuance. The current amount in the bond is \$3,500.00. Please increase the bond amount to cover the approved closing costs. Documentation from the Tallahassee Solid Waste Financial Coordinator will be used to determine if financial assurance instruments required by Rule have been submitted and approved.
