Thank you for your application for Solid Waste Transfer Station and Waste Tire Processing Facility Operation permit renewals for the above referenced Facility. The original permit application was dated February 18, 2016 and received February 18, 2016. A request for additional information (RAI) was issued on March 2, 2016, and the RAI response was received on March 24, 2016. The application, DEP Application No. 0173968-011-WT-31 and 0173968-012-SO, is considered complete. The Department will make every effort to issue the final agency action as quickly as possible.

Your RAI response submittal included a revised Table 1 "Opinion of Probable Closure Costs" for the Taft Recycling, Inc. facility. The document was signed and sealed by John P. Smith, P.E., of HSA Golden, Inc, Inc. on March 24, 2016. The document included recalculated estimated closing costs for the facility.

The total closing costs for the Taft Recycling, Inc. Transfer Station and Waste Tire Processing Facility provided in the Cost Estimate Form is estimated to be \$533,508.51

The closing cost estimate is approved by the Department.
