This letter is to acknowledge receipt of the subject facility's updated detailed closure cost estimates dated September 21, 2015 and received September 24, 2015 as Attachment D of the Southeast County Landfill Operation Permit Intermediate Modification Application. This cost estimate was prepared by HDR for the Hillsborough County Public Works Department, Solid Waste Division. This cost estimate provides Closure Cost and Annual Long Term Care estimates for the facility. The recalculated estimate(s) were submitted to comply with Rule 62-701.630(4)(a), Florida Administrative Code, (F.A.C.). The following cost estimates received on September 24, 2015 are **APPROVED for 2016**:

Phases I-VI and Waste Tire Site

Closing - \$21,501,831.18 Annual Long-term care - \$1,113,552.40 Total Long-term care - \$33,406,572.12 for 30 years

For Sections 7, 8 and 9

Closing-- \$5,274,672.89 Annual Long Term Care-- \$188.270.92 Total Long Term Care --\$5,648,127.54 for 30 years
