- MW-17 iron reported at 24,000 μg/L
- MW-20 iron reported at 160,000 µg/L

My apologies for adding an extra "0" to the result reported for well MW-17. My comments during the meeting about an order of magnitude increase in iron concentrations at well MW-17 compared to the previous sampling event were not correct. I've updated my spreadsheet accordingly.
