This letter is to acknowledge receipt of the inflation-adjusted cost estimates dated and received July 27, 2017, for closure and long-term care of the Citrus County Central Landfill and the supporting 2017 analysis of quantity of suitable soils for cover pertaining to the Restrictive Covenant and Access Agreement, Item 2.c, received August 28, 2018. The cost estimates received July 27, 2017 (total for closing \$6,007,641.91 and long-term care \$246,750.17/year x 30 years= \$7,498,737.67), are <u>APPROVED for 2017</u>. The approved estimates are for closing 32 acres and long-term care of 60 acres. The next annual update (revised or inflation-adjusted estimates) is due no later than <u>September 1, 2018</u>.
