#### ORDER CLOSING FILE

On June 21, 2017, the Florida Department of Environmental Protection (Department) received a petition for waiver from American Tire Recycling Group LLC., (Petitioner) for a Waste Tire Processing Facility located in Miami-Dade County, Florida. The Petitioner requested a waiver from paragraph 62-711.500(3), Florida Administrative Code (F.A.C.), which requires that owners and operators of waste tire processing facilities provide the Department with proof of financial assurance in the amount of the closing cost estimate for the facility. The petition requested the waiver to exclude processed material from closure cost estimates under the financial hardship and violations of principles of fairness provisions of Section 120.542, Florida Statutes (F.S.).

On July 19, 2017, the Department sent a Request for Additional Information to the Petitioner. On September 18, 2017, the Petitioner requested a 90-day extension for the submittal of its Response to the Department's Request for Additional Information.

On December 14, 2017, the Department received from Petitioner an email withdrawing its petition for a variance or waiver. See Exhibit 1. The Petitioner's withdrawal terminates the Department's jurisdiction to proceed with the variance or waiver process.

The petition having been withdrawn, the Department's file in this matter is closed.
