## **COMMENTS:**

This investigation was in response to a complaint alleging "...dumped thousands of old tractor and semi tires on the ground of their property..." and the complaint further alleges that the tires are piled to 20' high and many are very old and disintegrating. The complainant has a further concern that the toxins from the tires are impacting surrounding crops and the water supply.

The facility is permitted Waste Tire Processing Facility, authorized to have a maximum of 125,000 waste tires on site. Their operations include running routes to collect waste tires from Jacksonville and Ocala retailers.

Trailers are unloaded on to the ground where, useable tires are removed for resale and placed in trailers and the remaining tires are reloaded and sent to Argos (Cement Batch Plant) for use as fuel or to Liberty Tires (Jackson Georgia) for disposal. Liberty Tires provides the trailers used to transport the tires to their facility controlling the inbound flow.

The investigation determined that there were no greatly deteriorated tires, nor any tractor or semi-tractor trailer tires on site. Further, tire piles do not represent an environmental threat to the groundwater or surrounding crops. This permitted facility conducts a mosquito control program in accordance with their permit. While the number of tires on the ground greatly exceeds that of typical operations, the total number of tires on site does not appear to exceed the permitted maximum. This increase of tires on the ground is due to a temporary reduction of trailers provided by Liberty for disposal operations. Existing route trailers must be offloaded, in order to continue servicing contracted retail routes. No tire pile exceeded the 15' maximum. The quarterly report, due in January 2018, will document the total number of tires on site.

While the concerns alleged are considered invalid, several storage issues were observed. These include 1) piles greater than 50' wide, 2) piles greater than 10,000 square feet, 3) lack of a 50' wide perimeter road and 4) unobstructed access to the fire lane was not available. Per Department document "Guidelines for Characterizing Solid Waste Violations," single instances of each of these conditions do not represent violations. Should these conditions be observed during the next Level of Service inspection, they will be documented as violations. The Facility was advised to correct these issues within 30 days. No negative impacts to the environment were observed and no further action is considered necessary with regard to this complaint.
