Thank you for your application for a Waste Tire Processing Facility Permit Renewal for the above referenced Facility. The application, DEP Application No. 0297136-003-WT, is considered complete. The Department will make every effort to issue the final agency action as quickly as possible.

The Department has reviewed the Closure Cost Estimating Form for Solid Waste Facilities, form 62-701.900(28), which was included in Attachment 8 of the Application. The Form was certified by Dr. Maxwell R. Lee, P.E., of Koogler & Associates, Inc. The closing cost was estimated at \$6,432.00, which was calculated as the permitted capacity of 80.4 tons of tires stored at the facility multiplied by the estimated disposal cost of \$80 per ton. The estimated disposal cost was provided on January 9, 2019, by McGee Tire Company of Apopka Florida.

The closing cost estimate of \$6,432.00 is approved by the Department.

The most recent document received by the Department to demonstrate financial assurance was approved on October 9, 2014, for the amount of \$10,000. Please note, if the approved estimate includes a decrease in either the closing or long term care amounts, this communication is **not** authorization to decrease that amount in the financial instrument.
