Thank you for your application for an intermediate modification to Southeast County Waste Tire Processing Facility Operation Permit No. 126787-005-WT-02. The application dated December 27, 2018 was prepared by CDM Smith, Inc., and received on January 2, 2019. Based on the Department's review, the application is incomplete at this time.

In order for the Department to continue processing your application, please submit the information requested below as soon as possible:

- 1. Permit No. 1267787-005-WT-02 authorizes the use of processed tires as daily cover and in landfill construction. The application for this modification states the tires will no longer be shredded onsite and will be stored without specifying their use or final disposal method. Please provide the following information:
 - a. Proposed use or disposal method for the stored tires.
 - b. The maximum daily throughput, the planned daily throughput and the annual throughput.
 - c. A description of how 75% of the annual accumulation of waste tires will be removed for disposal or recycling. (Regulatory Reference 62-711.530(6) F.A.C.)
- 2. A description of stormwater control measures and measures to divert stormwater or floodwaters away from the storage piles. (Regulatory Reference 62-711.540(3)(a)).
