Dear Ms. Grant:

The Department has completed the review of the report titled “Construction Quality Assurance Certification Report for the Cell 6 Construction Project at the Vista Landfill – Apopka, Florida,” submitted by Carlson Environmental Consultants, PC., submitted on behalf of Vista Landfill, LLC. The report details construction of Cell 6 at the Vista Landfill.

The report was dated April 19, 2019 was received by the Department on April 22, 2019. As part of the report, the Certification of Construction Completion of a Solid Waste Management Facility, DEP form 62-701.900(2), was signed and sealed on April 19, 2019, by the Engineer of Record, Seth A. Nunes, P.E., of Carlson Environmental Consultants, PC. Additional proof of flushing of the leachate collection system was also received on May 20, 2019.

Based upon the review of the report, certification by the Professional Engineer of Record, and the inspection conducted at the facility on May 16, 2019, the Department concurs that the above referenced project was completed and is substantially consistent with plans and specifications approved by the Department Permit Modification No. SC48-0165969-019.

On May 14, 2019, Grove Scientific & Engineering submitted recalculated closure and long-term care cost estimates for Vista landfill which included Cell 6. The document is under review. Please note, no waste can be placed for disposal in Cell 6 until the financial assurance is approved and funded.
