This letter is to acknowledge receipt of the subject facility's updated detailed closure cost estimates dated and received January 15, 2020. This cost estimate was prepared by Jason Timmons, P.E., for SCCWDC. This cost estimate provides closure costs for Phase II (63 acres) and long-term care costs for Phase I (55 acres) for a total of 118 acres. The inflation estimate(s) were submitted to comply with Rule 62-701.630(4)(b), Florida Administrative Code, (F.A.C.). The following cost estimates received on January 15, 2020 are <u>APPROVED for 2020</u>:

Closing – \$17,102,237.53 Annual Long-term care – \$677,026.25 Total Long-term care – \$20,310,787.52 for 30 years

The next annual cost estimate update is due between January 1 and March 1, 2021.

The inflation factor is the result of dividing the latest published annual Deflatory by the Deflator for the previous year.
