- Appendix C Water Quality Monitoring. This comment is not specific to this application but is provided to acknowledge a ground water quality issue noted in the Departments inspection report dated July 1, 2020. This issue should be addressed concurrently with this application. The Primary Drinking Water Standard for sodium was exceeded in the samples collected from well TH-3 in May 2020. An increasing trend as well as exceedances and increasing trends of other leachate indicator parameters: TDS, chloride, and ammonia were also observed at TH-83. These results may be indicative of changing conditions in the areas outside of Phase II portion of the Southeast County Landfill which may require additional investigation and/or corrective actions. The Department requests an additional subsurface conductivity survey be conducted and compared to the results of past events. Once conducted, the Department requests a teleconference to discuss the results of this survey and any additional efforts to identify the source/cause of the increasing presence of indicator parameters in the area of TH-83.
