Good Morning Mr. Fischer,

I wanted to follow up in regards to the below status update. Upon review, it appears that the County has not obtained permitting through Solid Waste in Tallahassee nor ERP Permitting (SWD) regarding the current project underway. Following discussion with Mr. Ciaravella (Solid Waste in Tallahassee), the Department requests that an updated Operations Plan incorporating these changes is submitted in conjunction with the 5-year submittal due on March 24, 2021. During this time, the permit can be updated to reflect these changes as included in the updated Operations Plan.

In addition, it appears that a modification may be required for ERP. The SWD ERP section recommends the County set up a pre-application meeting to discuss the proposed changes to the SWMS. A pre-application meeting may be set up at the following link:

On behalf of the Manatee County Utilities Department, Solid Waste Division (County) SCS is providing FDEP a status update for this project. Per the original correspondence (in the attached letter previously provided) the project was anticipated to take approximately one year to fully complete and be online. Due to the unexpected conditions we all face due to COVID-19, the project has moved slower than was originally anticipated when the initial notice was supplied in August, 2019.

But to date, SCS has completed the design documents and the County advertised the solicitation on May 21, 2020. A site visit was conducted on May 28, 2020 with potential bidders and bids were submitted on June 18, 2020. Since that time Comanco has been awarded construction of the project. A pre-construction meeting was conducted on August 18, 2020 with SCS, the County, and Comanco. A notice to proceed (NTP) is anticipated to be supplied by the County to Comanco potentially the week of September 7, 2020. The project is anticipated to be completed and ready for final inspection within 45 calendar days from the NTP. This timeframe will be adjusted some due to the availability of materials such as concrete stormwater inlets and HDPE pipe. There is currently close to a month lead time for some of the materials to be manufactured and delivered for the project because of our current environment conditions.

Therefore, the County is anticipating the project will be completed and online by the end of the year. <u>Could you please respond accordingly to this email the proposed extended time frame is acceptable</u> <u>to FDEP</u>.
