Good morning Ms. Tejada,
I apologize for not responding earlier to your requests.
Regarding number 1 below. The rule requires you keep records of the following: For all waste tires shipped from the facility, the name and waste tire collector registration number of the waste tire collector who accepted the waste tires for transport, and the quantity of waste tires shipped with that collector; and if the waste tires were shipped with a person who is not a waste tire collector, the number of tires shipped, the person's name, address and telephone number; and the place where the waste tires were deposited; For all waste tires received at the facility, the name and waste tire collector registration number of the collector who delivered the waste tires to the facility, and the quantity of waste tires received from that collector; and if more than five waste tires were delivered by a person who is not a waste tire collector, the number of tires delivered and the person's name, address and telephone number; and, For all waste tires removed for recapping, the quantity and type removed, and the name and location of the recapping facility receiving the tires.
All of these may not apply but please provide copies of the records that do apply.
Regarding number 3. Below. The rule requires you keep records of the following: The operator of the site shall maintain records of the quantity of waste tires received at the site, stored at the site, and shipped from the site.
Also, regarding your comment to number 4. below. As I understood from you during the inspection you do collect tires from Serviteca in Osceola County. I also understand that Serviteca is owned by Jumbo Tires. Irrespective of ownership you do need to keep records of waste tire collection activities from Serviteca as required by Rule 62-711.520(6)(b), F.A.C.
