Citrus County recently performed the three-year Leachate Storage Tanks Cleaning and Inspection. This included draining each tank, removing all accumulated grit, disposing of the grit in the landfill, and cleaning each tank. While each of the tanks were drained and after cleaning, the North and South Tank were both inspected for any current concern areas or potential problems.

## **Tank inspection**

The leachate storage tanks are each 125,000-gallon, cast-in-place concrete tanks, and they were originally constructed in 1996. The last inspection was submitted in December of 2018, so this letter constitutes the update for the three-year inspection requirement. As a precautionary measure, the tanks are inspected in the daily operator log each day by an operator.

The photos below show the tanks in their current conditions. After cleaning and grit removal of the tanks, inspection showed no structural deficiencies. A few small blisters in the sidewall of the South tank were found above the normal leachate level but were noted to be of no immediate concern. It was determined that the blisters will be monitored closely for any changes, but that they would be repaired in a re-coating in the future.

## **Conclusions**

No potential issues were identified with the structural integrity of the tanks. There were a few small blisters in the interior coating above the normal leachate level line that do not pose a problem in the containment of leachate. Citrus County is planning for a future recoating of the interior walls at a later date that has yet to be determined.

Citrus County Utilities and the Solid Waste Departments will continue with regular maintenance and inspections of the Leachate Storage Tanks in order to continue to provide proper storage and environmentally sound handling of the leachate. The next leachate storage tank inspection report will be due to FDEP in October 2024.
