- 1. Operation Plan: Please provide an updated Operations Plan with the following revisions in accordance with 62-701.500(2), F.A.C.:
 - a. Has the Class III Cell 6 accepted waste for disposal? If so, please revise Section 6.1 of the Operation Plan to include cell 6.

Cell 6 has accepted waste for disposal. Operation Plan Section 6.1 is revised to include Cell 6.

c. Update the Operation Plan to include the revisions provided in the application.

Response

The enclosed Operation Plan dated July 14, 2021 is updated to include the revisions provided in this application.

2. Please note the Solid Waste Construction Permit No. SC48-0165969-019 authorizing the construction of Phases I and II, cells 3-8 was issued on 10/30/2012 and expired on 08/28/2017. The facility will need to apply for and receive a new construction permit prior to construction of Phase II cells 7 and 8. 62-701.320 (1) F.A.C.

3. Please provide a status update on the Gas Collection System Expansion construction included in the 7/6/2020 notification email. Please note the Gas Collection System Expansion was approved in the 2/26/13 Solid Waste Operation Permit No. 0165969-020-SO which incorporates-018, -021, and -022. This modification included the Gas Collection System Expansion in cell 1 through cell 4. An operation permit modification to the operation permit will need to be authorized prior to additional expansion of the gas collection system. 62-701.320 (1) F.A.C.

Response

The Certification Report for the Gas Collection System Expansion construction included in the 7/6/20 notification email was submitted via email on 8/25/20. It was resubmitted to DEP_CD@dep.state.fl with copy to you on July 13, 2021. Please see the enclosed submittal confirmations.

It is acknowledged that additional expansion in future Cell 7-12 requires an operational permit modification to the Operation Permit prior to construction.

4. Please note the Solid Waste Construction / Operation Renewal Permit — Waste Processing Facility No. 0165969-025-SO-31 issued on 4/9/2015 expired on 3/27/2020. The Material Recovery Facility was never constructed therefore language in the Operation Permit pertaining to the Waste Processing Facility has been removed.
