Hello Melissa, the purpose of this email is to provide notification per the LMP Table 9.2.4. From July to date the landfill has received 33 inches of rain which resulted in an increased leachate generation. From September 17<sup>th</sup> through the 23<sup>rd</sup>. Monitoring port 2-1 exceeded 30 inches. As of today the level at CO 2-1 has returned to below 30-inches (28.6). Per action Table 9.2.4 we have taken the following actions:

- 1. On the 21st began evaluating Pump Station 2 to confirm performance.
- 2. On the 23<sup>nd</sup> flushed the suction line of Pump Station 2.
- 3. In the event is needed, installed a temporary diesel pump at cleanout 2-2, currently on standby.

We will keep monitoring the system and will keep you updated as to the status, please let me know if you have any questions. Thank you.
