This letter is to acknowledge receipt of the subject facility's updated detailed closure cost estimates dated November 19, 2021 and received December 1, 2021 as Appendix H in the Application for Intermediate Permit Modification. This cost estimate was prepared by SCS Engineers for Tomoka Farms Road Landfill – North Cell, Class I. This cost estimate provides detailed costs for closure and long-term care for 90.68 acres. The recalculated estimate(s) were submitted to comply with Rule 62-701.630(4)(b), Florida Administrative Code, (F.A.C.). The following cost estimates received on December 1, 2021 are **APPROVED for 2022:**

Closing – \$18,652,868.25 Annual Long-term care – \$364,648.96 Total Long-term care – \$10,939,468.65 for 30 years

The next annual cost estimate update is due between July 1 and September 1, 2023.
