Dear Mr. Condron:

In response to the major permit modification request submitted August 19, 2004, the Department is granting your request to operate the Taft Recycling, Inc. Materials Recovery Facility, and add processing and transfer areas for Class I municipal solid waste (MSW).

Specific Conditions 13 and 20 of Permit No. SO48-0173968-002 are revised and Specific Conditions 27 through 31 are added to Permit no. SO48-0173968-002. In response to the applicant's letter of request, dated January 11, 2005, the solid waste processing rates for Class I and Class III waste have been further revised to more closely reflect anticipated processing rates.

- 13. <u>Allowable Waste</u>: This facility shall process wastes that are acceptable for disposal at a Department permitted Class I and Class III landfill.
- 20. <u>Solid Waste Processing Rate</u>: The solid waste processing rate for this source is an average of 600 tons/day for Class I and 400 tons/day for Class III. Actual operating rates may vary depending upon business conditions.
- 27. <u>Transfer Station Requirements</u>: The facility shall meet all applicable requirements of Rule 62-701.710, F.A.C., Waste Processing Facilities.
- 28. Record Keeping: The facility shall meet the record keeping requirements of Rule 62-701.710(9), F.A.C.
- 29. <u>Leachate Generation From Transfer Operations:</u> Leachate shall be stored in the 5,000 gallon above-ground tank, and transported by an industrial waste hauler in a 4,000 gallon vacuum tanker to a State Permitted industrial wastewater treatment plant, such as IWS, Jacksonville, Florida.
- 30. <u>Mixed Waste Disposal:</u> If wastes are mixed, the waste must be disposed of as the highest category of wastes, e.g., Class III mixed with Class I, shall be disposed of at a Class I landfill.
- 31. <u>Certification Requirements:</u> The facility shall meet the certification requirements of Rule 62-701.710(5), F.A.C. After all specified construction has been completed, the engineer of record shall certify to the Department on Form 62-701.900(2) that the permitted construction was completed in accordance with the plans submitted to the Department except where minor deviation was necessary. The engineer of record shall provide a detailed description of all deviations, with an explanation of why each deviation was necessary. The facility may not operate under the terms of this permit modification until the Department inspects the completed construction and provides a letter accepting the certification to the permittee.
