This letter is to acknowledge receipt of the inflation-adjusted cost estimates dated February 20, 2009 (received February 23, 2009), for closing of the Florida Crushed Stone Waste Tire Processing Facility. The inflation-adjusted cost estimates received February 23, 2009 (total for closure \$21,972.35), are **APPROVED for 2008**. The approved estimates are for a total of approximately 205 tons of waste tires at the site at any time. The next annual update (revised or inflation-adjusted) was due March 1, 2009. The above referenced facility has experienced no changes and is operating in compliance with the permit requirements. The maximum quantity of tires allowed to be stored on site is 205 tons. The anticipated disposal cost for the maximum storage quantity is calculated as follows:

2007 Disposal Cost Estimate = \$21,332.38FDEP Inflation 2008 Multiplier = 1.032008 Disposal Cost Estimate (1.03 x \$21,332.38) = \$21,972.35
