Approval of Closure and Long-Term Care Cost Estimates

Dear Mr. Marion:

The Department has reviewed the two documents "Financial Assurance Cost Estimate Form" for Tomoka Farms Road Landfill – Phase I, Class I and Tomoka Farms Road Landfill – South Cell and the Class III Landfill. Each document is dated August 31, 2009. The documents were signed by you and also signed and sealed Carlos Lebron, P.E. The inflation adjustment factor of 1.02 was used to calculate the closure and long-term care estimates.

For Tomoka Farms Road Landfill – Phase I, Class I, the closure cost is estimated at \$10,611,429.96. The long-term care cost for 30 years is estimated at \$3,733,824.53.

For Tomoka Farms Road Landfill – South Cell the long-term care cost for 30 years is estimated at \$5,042,788.81.

For Tomoka Farms Road - Class III Landfill the closure cost is estimated at \$7,784,680.80. The long-term care cost for 30 years is estimated at \$2,729,367.92. The cost estimates are approved by the Department.
