Dear Mr. Merrifield:

The Department of Environmental Protection (Department) received your permit application for a waste tire processing facility known as Tire Disposal Services (DEP File Number 0064386-004-WT; Facility Identification No. 6475) located at 3053 Barnes Lane, Cottondale, Jackson County, Florida 32431. The Department received your application on July 13, 2010.

Given the controversial nature of solid waste management facilities in the Northwest District, in accordance with Rule 62-110.106(6), Florida Administrative Code, the Applicant shall publish, at the applicant's own expense, a Notice of Application in a newspaper of general circulation in the area where the facility is located and provide proof of publication to the Department within seven days of publication. "Publication in a newspaper of general circulation in the area affected" means publication in a newspaper meeting the requirements of Sections 50.011 and 50.013 of the Florida Statutes, in a county where the activity is to take place. Where there is more than one newspaper of general circulation in the county, the newspaper used must be one with significant circulation in the area affected by the permit. If you are uncertain that a newspaper meets these requirements, please contact the Department at the address or telephone number listed below.
