Dear Mr. Merrifield:

The Department of Environmental Protection (Department) received your permit renewal application on July 13, 2010, for a waste tire processing facility known as Tire Disposal Services (DEP File Number 0064386-004-WT; Facility Identification No. 6475) located at 3053 Barnes Lane, Cottdale, Jackson County, Florida 32431. This letter constitutes notice that approval will be required for your project pursuant to Chapter 403, Florida Statutes (F.S.) and Rule 62-711.530, Florida Administrative Code (F.A.C.)

Your application for permit is incomplete. Please provide the information listed below promptly. Your response is due on or before November 1, 2010, which is 90 days after the date of this letter in accordance with Rule 62.4.055(1), F.A.C. Evaluation of your proposed project will be delayed until all requested information has been received.

1. Part I, Section A.7 of the application for enforcement action history was checked "No". However, a review of the facility files indicates a short form consent order was executed on September 13, 2005. Please revise the application to indicate "Yes" and resubmit the application along with the appropriate enforcement action history and description.
2. The site plan submitted was not signed and sealed by a Professional Engineer Registered in the State of Florida as required by Part III, Section A of the permit application. Please provide a site plan or plot plan in accordance with Part III, Section A.2 of the application that is properly signed and sealed.
3. A recent (not more than one year old) zoning and land use map of the surrounding area for one mile was not provided as required by Part III, Section A.1 of the application. Please provide the required document.
4. The cost estimates are not approved. In an email (enclosed) from Terence T. Rawlins, U.S. Bank Corporate Trust Services, to Susan Eldredge, of the

Department, it is noted that for Standby Trusts, an annual fee of \$500 would be charged at inception, that fee would remain constant for trusts that hold assets of \$50,000 or less and became funded trusts. Therefore, the cost estimates should be revised to include this annual fee, in order to ensure that an appropriate amount of financial assurance is available for closure. Please contact Susan Eldredge, at the address below, if you need assistance with this item.

5. Once closing cost estimates are approved, proof of financial assurance for this facility in the name of the permit applicant must be provided. Documentation from the Department's Solid Waste Financial Coordinator will be used to determine if financial assurance instruments required by Rule have been submitted and approved. Hi Susan,

Further to our earlier conversation regarding fees in connection with Standby Trusts, I confirm that we would charge an annual fee of \$500 at inception, that fee would remain constant for trusts that hold assets of \$50,000 or less and became funded trusts. Trusts holding assets in excess of that amount up to \$500,000 would see an increase in the fee amount to \$1,000 per year once they became funded trusts.
