PART 1, A.1 and C.1: The applicant's and owner's name is not complete as it appears on the submitted copy of the Annual Report to the State of Florida. Please enter the complete name, Beck's Tire Service, Inc., and resubmit the application form. Please submit a complete copy of the Annual Report; the submitted one is missing the title (upper line) [F.A.C. Rule 62-701.900(23)].

PART II, B: Please add "including regrooving and repairing" after "Transfer Station" [F.A.C. Rule 62-701.900(23)].


PART III, C.1: Please review the closure cost estimate, as it does not appear correct. Please submit the closure cost estimate with the name of the facility and its location at the top and the title "Closure Cost Estimate." Please do not use the abbreviations for its name, etc., in the text. The calculations shall reflect the maximum storage quantities reported on Page 2 of 4 of the application form, not the quantities on hand at the time of an inventory. The document shall be signed by the owner/operator, and signed, dated and sealed by the professional engineer [F.A.C. Rule 62-711.700(2) and (3)].

PART III, E: Please clarify who the land owner is and submit a letter from the land owner authorizing use of the land as a waste tire processing facility [F.A.C. Rule 62-701.900(23)].

PART IV, A: Please clearly write or type the complete name of the applicant, "Beck's Tire Service, Inc." The letter of authorization submitted in PART III-E-1 is not from the applicant; it shall be from the applicant, Beck's Tire Service, Inc., and signed by its president [F.A.C. Rule 62-71.900(23)].
