The Department of Environmental Protection (Department) received your October 1, 2010, response to the Department's August 3, 2010, request for additional information letter for your permit renewal application (DEP File Number 0064386-004-WT; Facility Identification No. 6475) located at 3053 Barnes Lane, Cottondale, Jackson County, Florida 32431. This letter constitutes notice that approval will be required for your project pursuant to Chapter 403, Florida Statutes (F.S.) and Rule 62-711.530, Florida Administrative Code (F.A.C.)

Your application for permit is incomplete. Please promptly provide the information listed as incomplete below. The numbered items below directly correspond to those listed in the August 3, 2010, request for additional information letter. Your response is due on or before January 12, 2011, which is 90 days after the date of this letter in accordance with Rule 62.4.055(1), F.A.C. Evaluation of your proposed project will be delayed until all requested information has been received.

- 5. Closing cost estimates are approved for \$3,500.00. Proof of financial assurance for this facility in the name of the permit applicant must be provided. Documentation from the Tallahassee Solid Waste Financial Coordinator will be used to determine if financial assurance instruments required by Rule have been submitted and approved.
