Subject: FTR

On March 2, 1994, I personally hand delivered a copy of the entire Settlement Agreement (SA) and Ed Spahn's fire plan of October 1993 to Captain Vaughn of the SLCFPFCD. As you will note, there is a letter dated March 1, 1994 from Skip Robinson to Captain Vaughn that quotes Capt. Vaughn as stating that he cannot review the proposed fire plan submittal pursuant to the SA by FTR, without first having received a copy of the aforementioned documents from DEP.

Capt. Vaughn stated that he'd copy us on any letters he sends to FTR and I stated that we'd do the same. Capt. Vaughn has asked for copies of any letters sent by us to FTR since the executed date of the SA. I told him that we would send the letters via Stacy Koch, our secretary.

RE: FIRE PLAN REVIEW

Dear Captain Vaughn,

Thank you for returning my calls yesterday after several missed attempts on both of our parts (telephone tag).

I write now to acknowledge our conversation of yesterday in which you confirmed that you had received our Site Plan and Emergency Manual, had discussed the same with Captain Sessoms and feel "comfortable" with the material.

Further, I understand from you that until such time as you receive a copy of the State's Plan, you are unwilling or reluctant to formalize a response to the review process which we have requested.

As I explained during our conversation, we are currently operating under a court ordered Stipulation which requires that we, "prepare a fire plan acceptable to the St. Lucie County Fire District that describes the detail of fire fighting resources available to fight a fire at the FLORIDA TIRE site. The Fire Plan shall be submitted to DEP within 30 day of entry of the Stipulation order period". Since the Stipulation was entered on January 14, 1994, the FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION has cited us as being in non-compliance because we have not received a notice of your acceptance of our plan.




