

## ORDER OF SITE PLAN APPROVAL

#### AN ORDER GRANTING A MAJOR ADJUSTMENT TO A SITE PLAN PROJECT KNOWN AS FLORIDA TIRE RECYCLING

WHEREAS, the St. Lucie County Community Development Director has reviewed the application for a major adjustment to a minor site plan project submitted by John Wilson, and has reviewed the comments of the St. Lucie Development Review Committee on this application, and makes the following determinations:

- The relocation of an approved 15,000 square 1. foot building, tire storage areas, and stormwater improvements within a site plan project known as Florida Tire Recycling has been proposed. The proposed adjustment also provides for a cross ingress/egress easement.
- 2. The Development Review Committee has reviewed the proposed adjustment and has found it to meet all technical requirements of the Land Development Code and to be consistent with both the existing zoning and future land use maps from the St. Lucie County Comprehensive Plan.
- The proposed project is consistent with the general purpose, goals, objectives, and 3, standards of the St. Lucie County Comprehensive Plan and the St. Lucie County Land Development Code.
- The proposed project will not have an undue adverse effect on adjacent property, the character of the neighborhood, traffic conditions, parking, utility facilities, or other matters affecting the public health, safety and general welfare.
- 5, All reasonable steps have been taken to minimize any adverse effect of the proposed project on the immediate vicinity through building design, site design, landscaping and screening.
- The proposed project will be constructed, 6. arranged and operated so as not to interfere with the development and use of neighboring

property, in accordance with district regulations. 7. The proposed project is to be served by adequate public facilities and services. 8. The applicant has applied for and has received a Certificate of Capacity for this adjustment, a copy of which is attached to this Order as Exhibit A, as required under Chapter 5, St. Lucie County Land Development Code. The applicant has obtained from the St. Lucie 9. County - Fort Pierce Fire Prevention Bureau written confirmation that water supply, evacuation facilities, and emergency access are satisfactory to provide adequate fire

protection.

THEREFORE, BE IT ORDERED by the Board of County Commissioners of St. Lucie County, Florida:

- Pursuant to Section '11.02.03(D) of the St. Lucie County Land Development Code, the site plan for the proposed project known as Florida Tire Recycling be, and the same is hereby approved as shown on the site plan drawings for the project prepared by Joseph T. Friscia, P.E. Inc., dated June 14, 1995, and revised through July 20, 1995, and date stamped received by the St. Lucie County Community Development Director on July 28, 1995 with the following conditions:
  - Prior to the issuance of a building permit a copy of this projects Management and Storage of Surface Water Permit must be provided to the Department of Community Development and approved by Department of Engineering.
  - Prior to the issuance of a building permit a recorded copy of the "Right-of-way Consent Agreement" between Florida Tire Recycling and Florida Power and Light Company shall be provided to the Department of Community Development.

- 3. Prior to the issuance of a building permit proof of Florida Department of Environmental Protection authorization to operate the Waste Tire Processing Facility must be provided and approved by the Department of Community Development.
- B. The property on which this development will take place is described as follows:

Commence at the Northeast corner of section 1, Township 37 South, Range 38 East, St. Lucie County, Florida; thence run \$00°00'54"W, along the East line of said section 1, a distance of 1907.98 feet, to the POINT OF BEGINNING; thence continue \$00°00'54"W, along the East line of said Section 1, a distance of 660.00 feet; thence run \$00°00'54"E, a distance of 1320.00 feet; thence run \$00°00'54"E, a distance of 1242.49 feet; to the South right-of-way line of the Florida East Coast Railroad; thence run \$40°00'54"E, a distance of 884.93 feet; thence run \$00°00'54"W, a distance of 884.93 feet; thence run \$00°00'54"W, a distance of 1210.93 feet; thence run \$00°00'54"W, a distance of 1210.93 feet; thence run \$00°00'54"W, a distance of 696.98 feet, to the POINT OF BEGINNING; all lying and being in section 1, Township 37 South, Range 38 East, St. Lucie County, Florida and containing 32.8252 Acres, more or less, and subject to a 560 feet Florida Power and Light Easement.

Should the property owner, developer or authorized agent wish to appeal any condition described in Section A above, all such appeals must be filed in writing with the County Administrator within thirty (30) days of the rendering of this Order, AB described in 11.02.03(B), St. Lucie County Land Development Should an appeal to this Order be no permitting reviews or further administrative action shall take place on the processing of this development project until the appeal is resolved.
- D. The applicant has applied for and received a Certificate of Capacity a copy of which is attached to this order as Exhibit A, as required under Chapter V, St. Lucie County Land Development Code.
- E. A copy of this Order shall be mailed, return receipt to the developer and agent of record as identified on the site plan application.
