Dear Mr. Bischoff,

Waste Tire Collector <u>Decal # 1849</u> have been assigned to replace <u>Decal # 707</u> that you have reported to this office as no longer in use. Decal # 1849 has been assigned to a 2004 International Truck, Tag # G697KP and Decal # 1850 has been assigned to a 1999 International Truck, Tag # 364XTY. **Decal # 707** can no longer be used.

Waste Tire Collectors are subject to the following specific conditions:

- 1) The decal supplied by the Department shall be displayed on the outside of the driver's front door. Common carriers may display the decal on a removable panel.
- 2) Records shall be maintained for three years and will be available for inspection by Department personnel during normal business hours. The records will be summarized quarterly and will contain the following:
 - a) Quantity of tires collected.
 - b) Where and from whom tires were collected.
 - c) Where the waste tires were deposited.
 - d) Receipts or other written materials documenting the above.
- 3) A Waste Tire Collector Annual Report (DEP Form 62-701.900(22)) shall be submitted by March 1 of each year.
- 4) A Registration Renewal Application (DEP Form 62-701.900(18)) shall be submitted by March 1 of each year to renew this registration.
- 5) A Waste Tire Collector shall leave waste tires and processed tires for storage and disposal only in a permitted waste tire processing or collection facility, at a permitted solid waste management facility, or at another site approved by the Department.
- 6) Any person who fails to comply with these conditions is subject to having their Waste Tire Collector Registration revoked, as well as other penalties provided by law.
- 7) When a Waste Tire Collector Registration number expires or is revoked, the registration decals shall be removed from all vehicles immediately.

IMPORTANT_INFORMATION

SECTION 320,0605, Florida Statutes, requires this registration certificate or an official copy or a true copy of a rental or lease agreement issued for the motor vehicle described be in possession of the operator or carried in the vehicle while the vehicle is being used or operated on the highways or streets of this state.

SECTION 316.613, Florida Statutes, requires every operator of a motor vehicle white transporting a child in a passenger car, van or pickup truck registered in this state and operated on the highways of this state, shall, if the child is 5 years of age or younger, provide for protection of the child by properly using a crash-tested, federally approved child restraint device. For children aged through 3 years, such restraint device must be a separate carrier or a vehicle manufacturer's integrated child seat, for children aged 4 through 5 years, a separate carrier or seat belt may be used.

SECTION 627.733, Florida Statutes, requires mandatory Florida No-Fault Insurance to be maintained continuously throughout the entire registration period; failure to maintain the required coverage could result in suspension of your driver license and registration.
