Dear Mr. Wilson:

As requested, we have prepared a cost estimate the closure of your facility and have based our calculations on our letter dated July 20, 1992, in which we estimated the quantity of unprocessed tires presently stored at your facility.

The passenger tire estimate is based upon the disposal costs quoted by the Solid Waste Authority of Palm Beach County in their correspondence of July 29, 1992. The cost of transportation to Palm Beach County has been estimated at \$4.10/Ton, an average between the two estimates submitted.

The truck tire estimate is based upon the disposal cost at the St. Lucie County Landfill at \$80.00/Ton and a transportation cost of \$2.05/Ton.
The cost of disposal is as follows:


