Hi Tiffany –

Here is the check I submitted with our original renewal for Used Oil and Oil Filter Handlers in February. At that time I had submitted our ILR transporter # for the 3 facilities so we enclosed a check for \$300. Based on our conversation in late March/early April we agreed it made more sense to submit a 8700 – 12FL form for our ILR # which I submitted on April 22<sup>nd</sup>. This Form was checked for Haz Waste, Used Oil and Oil Filter transporter. I think that made for an overpayment of \$200?

I haven't checked to make sure that this check was cashed, but I can check with our accounting department if you can't find any documentation.

I received Aprilia's e-mail yesterday on the transfer facilities and am working with my boss to get this information. If you have any questions, please feel free to contact me.
