### **General Comments**

- **1. Renewal Permit Application:** Rinker Materials of Florida, Inc., Miami must submit a standalone document with detailed and updated site specific information for the revised renewal permit application inserting page number on each page.
- **2.** The text on the figure under Rev-2 Att. 1-Facility Diagram is not readable. Please provide a bigger Facility Diagram. For the tanks identified in the Facility Diagram as closed, please provide what was stored on those thanks and when the tanks were closed.
- **3.** Site Map and Tank Table: Please provide a site map (8 ½"x11") in electronic format (PDF) identifying all tanks and also a tank table (8 ½ "x11") in electronic format (PDF). Please send the map and tank table via e-mail, so that the map and tank table can be attached to the permit. Also include hard copies of the map and tank table with your response.

## **Specific Comments**

- 1. Attachment 2: Facility Operation, Activities conducted: The statement under bullet three should read "Thermal treatment of petroleum-contaminated soil "and" non-hazardous coal tar contaminated soil. Please revise as appropriate.
- 2. Attachment 3: Detailed Process Description: The test performed for the incoming loads does not meet the requirements of a Waste Analysis Plan per Parts 270.14(b)(30), 264.13(b)(c) and 268.7 as there is no indication of sampling methods, frequency (refers to per load; how big is load) and it does not provide test methods for metals analysis. Neither does it meet Subpart G; the Rebuttable Presumption per Part 279.63, as it does not indicate equipment used calibration methods and frequency, sampling methods, or frequency (how many gallons between sampling), etc.
- **3. Emergency Preparedness Section:** The Emergency Preparedness Section does not specifically mention explosions per Part 264.52(a) or a spill control plan per Part 264.52(b). Please review and revise as appropriate.
- **4. SPCC Section:** The SPCC Section does not specify whether on scene line supervisor or operations manager can allocate funds for spill cleanup if beyond scope of facility response team per Part 264.55. Please revise as appropriate.

- **5.** The telephone numbers of the nearest fire station, police station and hospital should be provided, not just 911 per Part 262.34. Please revise as appropriate.
- **6. Security:** Issue of surveillance, signage, barriers, etc., per Parts 264.14 & 270 .14(b)(4) should be addressed in the application. Please revise the application.
- **7. Emergency Preparedness and SPCC:** As per Parts 264.52(e) and 262.34, the facility should provide a list of emergency equipment with location, description and capabilities.
- 8. **Personnel Training:** As per the requirements Parts 270.14(b)(12) and 264.16, attach a copy of facility's employee training for used oil management. This attachment should describe the methods or materials, frequency, and documentation of the training of employees in familiarity with state and federal rules and regulations as well as personal safety and emergency response equipment and procedures. Please revise as appropriate.
- **9. Unit Management:** Attach a description of the facility's unit management for tanks and containers holding used oil. This attachment must describe secondary containment specifications, inspection including a schedule for general facility inspection, and monitoring schedules and corrective actions. As per Parts 262.34, 264.174 and Rule 62-730.160(6), the facility should inspect the containers weekly and keep a copy of the inspection log at the site.
- **10. Facility Closure Plan:** Attach a copy of the facility's Closure plan and schedule.
