Edits to spill control and training:

1. Spill control should read as an S.O.P. specific to your company (e.g. list of spill control equipment on hand in each truck, the contact number for the clean-up contractor you have on call, I would imagine someone from management might like a phone call reporting an incident, etc.).
2. The training program should include the specific items/language you would expect to use in your training program (writing out the details of each training point listed on the checklist that you've used as your training program. It should also indicate the frequency of training as well as where training records are kept.
3. Do we have a copy of your halogen S.O.P.?

We can work this out as soon as these deficiencies are corrected.
