Dear Ashmore:

The purpose of this letter is to provide notice that the permit numbered 0294693-**011-HO** & 0294693-**012-SO** will expire on **May 12, 2025**. Prior to sixty (60) calendar days before the expiration of this permit, an application for the renewal of the permit shall be submitted on forms¹ and in a manner prescribed by the Department and as stated in your permit. Please ensure that your DEP Form 8700-12FL is current, as this information is reviewed during the permit renewal process. The application shall meet the fee requirements of Rule 62-4.050 and Rule 62-710.800(4), Florida Administrative Code (F.A.C.).

A timely and sufficient application and processing fee are due by March 13, 2025 (60 days prior to expiration), in accordance with Rule 62-4.090, F.A.C. If the renewal application is submitted at a later date, it will not be considered timely and sufficient unless it is submitted and made complete prior to the expiration of the permit. When the application for renewal is timely and sufficient, the existing permit shall remain in effect until the renewal application has been finally acted upon by the Department.
