Dear Mr. Coyne:

This is in response to your letter dated June 28, 2010 concerning name change from Hydrocarbon Recovery Services, Inc. to FCC Environmental, LLC. To incorporate the name change request in the Used Oil Processing permits, we have received and reviewed. Please provide for each of the Hydrocarbon Recovery Services, Inc. facilities as listed in Table 1 the following: (1) an updated Part A permit application; (2) Notification Form 8700-12FL; (3) an application for notification of the name change [DEP Form #62-701.900(8)]; and (4) a fee of \$50.00 for each facility. Also, update the Used Oil transporter insurance certificates to all the facilities if appropriate.
