Water Recovery, LLC (WRI) has prepared the following response in accordance with the above referenced letter dated November 4, 2010.

With respect to potential violations and areas of concern numbered 1,2,3,4, & 7 and as noted in your report, the facility has returned to compliance and no further action is required.

With regard to record review item #5 WRI will adopt the specific corrective action as recommended in the report. Beginning January 1, 2011, the facility will record the amount of product recovered from all PCW it receives and maintaining records on-site so it will be able to submit an annual report by March 1, 2012, and subsequent years.

With regard to item #6, WRI has taken corrective action to ensure that incoming shipments of industrial waste water displaying a visible sheen will receive TOX screening. WRI has amended its Used Oil Waste Analysis Plan, Management Procedure 4100 and Employee Used Oil Training documentation accordingly and submitted them to the Department under cover letter dated November 19, 2010 in connection with the facilities Used Oil Processor's Permit renewal application. The corrective action proposed through these amendments has been implemented, effective immediately, by Management and operating personnel.

Please do not hesitate to call me directly if we can provide further assurance. As always, the efforts of both you and the Department in assisting WRI with regulatory compliance are greatly appreciated.
