Ms. DePaola:

The mercury recovery permit for the AERC.COM, Inc facility located at 4317-J Fortune Place, West Melbourne, Florida expires December 30, 2011. Your renewal application is due no later than July 03, 2011. We strongly suggest you contact Bheem Kothur at Bheem.kothur@dep.state.fl.us or 850-245-8781 to schedule a pre-application meeting.

The Central District office of the Department of Environmental Protection inspected your facility on December 16, 2009 and noted in their final inspection report that mercury containing material other than mercury-containing lamps and devices were being consolidated and stored in the 90-day storage area prior to shipment to a mercury reclamation facility. The report also notes that the 10-day transfer area contained wastes received with the D009 waste code plus additional waste codes prior to being transferred to the AERC facility in Pennsylvania.

The mercury recovery permit that AERC.COM, Inc. currently has was issued where the operations or processes are performed or equipment is used to receive and process spent mercury-containing lamps or devices for the purpose of crushing or dismantling and separating the lamps or devices in a manner as to produce: separated, individual recyclable components such as glass and scrap metal; and mercury-containing phosphor powder or other mercury-containing residuals that will be processed at a mercury reclamation facility for the purpose of reclamation of the mercury.

Your facility also has an authorized 10-day hazardous waste transfer facility. The 10-day transfer facility is for hazardous waste in transit to a permitted treatment, storage, or disposal facility. Hazardous material, such as material with the D009 waste code, in transit to a permitted treatment, storage, or disposal facility can be stored and consolidated for no more than 10 days in the 10-day transfer facility. The consolidation of material in the 10-day transfer area does not

generate a new waste or a new generation date but retains the date of the oldest material consolidated.
