To answer your question regarding parts washers:  
We loan out and sell only "virgin parts washers" and sell the non-hazardous parts washer solution; we NEVER pick up any parts washer fluid under any circumstances, if we are ask to do so we advise the customer to contact a hazardous waste disposal company.

We are full aware of the possibility that a non-hazardous fluid can be made hazardous by the introduction of a hazardous material into it.

Sure thing Jerry. I will not be there, but a couple of my counterparts will be leading the training.

As for the parts washers, are you guys collecting the spent washer fluid too or just selling the virgin product? There are not special regulations over parts washers, but spent parts washer fluid is subject to the hazardous waste determination requirements. The fluid itself may be non-hazardous as a waste, but if the user adds any brake cleaner or other solvents to it (for example if they spray a part over the parts washer, the solvent may get in the machine) it may become hazardous at that point. I've also known facilities that will dump paint and thinner into their washers, which may change their status. The generator of the spent washer fluid would be responsible

for making the hazardous waste determination. The trainers should cover this a little during the training on the 21st.

Program Description: Many businesses, both large and small, use various hazardous materials in the interest of commerce. Many of these commercial processes produce wastes, and a portion of these wastes may be hazardous. The method a business manager employs to manage hazardous waste(s) can have a direct influence on business profits and future liabilities for the property, the business, and its owners. In 1976, the Resource Conservation and Recovery Act (RCRA) was enacted by Congress to protect public health and the environment from improper management of hazardous waste. Since the initial enactment, RCRA has been amended to regulate the previously exempted small quantity generator (SQG). The State of Florida has adopted by reference the federal regulations governing the Small Quantity Generator.

Instructor: Ms. Pam Fellabaum and/or Ms. Tami Applebee with Florida Department of Environmental Protection

Program Cost: This program is provided free of charge by the NEFRC in partnership with Baker County and Nassau County Small Quantity Generators (SQG) Program.
