According to Department records, the most recent Used Oil Transporter (UOT) registration we have on file for your facility is dated 1997. Pursuant to subsection 62-710.500(2), Florida Administrative Code (F.A.C.), the UOT registration must be renewed annually by submitting the required documentation no later than March 01 of each year.

Since the Department did not receive the required documentation for your facility, your registration expired on July 01, 1998. Transporting UO without a valid registration is a violation of the law, subject to penalty.

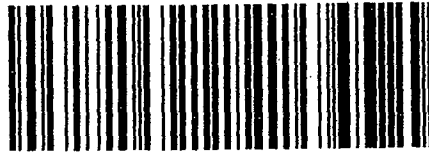

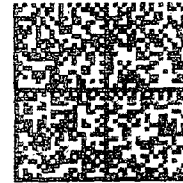

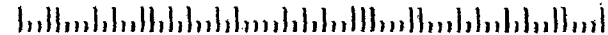
