Dear Mr. Bosek:

We appreciate the prompt review of your draft permit renewal. A few explanations you requested are noted in the following comments:

Condition Part I.14.e: The written operating record can include electronic records so long as they are readily available for inspections and the information can be readily printed, if needed.

Condition Part I.33: Because Clean Harbors is not the land owner, the City of Bartow (landowner) will be responsible for compliance with this condition as a co-permittee. The City will be added to the first page of the permit as we have done with other permits under similar circumstances.

Condition Part II Subpart A.1: For the purposes of permit compliance, the notification for receipt of hazardous waste from a foreign source should be copied to FDEP in the Tallahassee and Tampa offices. An electronic notification is acceptable for the Department.
