Introduction:

Ranger Construction Industries, Inc. (Ranger) does road building and heavy highway construction. The facility is approximately 10 acres in size, is on public utilities, has five employees, and has been at this location since the 1980's.

This is the first time the Department inspected this facility.

Process Description:

The facility's operations as a cement plant does not generate hazardous waste.

During the inspection the facility representative requested that the inspector contact Ranger's environmental manager Jo Moore, regarding the inspection. Though the facility does not appear to generate hazardous waste Ranger has elected to be a Conditionally Exempt Small Quantity (CESQG) level for possible future potential.
