The petition must contain the information set forth below and must be filled (neceived) in the Departments Office of General Counsel, 3900 Commonwealth Boulevard, Mail Station #35, Tallahassee, Florida 32393-3000. Petitions filled by the permit applicant and any of the parties listed below must be filled within fourteen (14) days of receipt of this Intent, Petitions filled by any persons other than those entitled to writreceipt of this Intent. Petitions filled by any persons other than those entitled to written notice under section 120.60(3) of the Florida Statutes must be filled within four-teen (14) days of publication of this notice of Intent or receipt of the written notice, whichever occurs first. A petitioner shall mail a copy of the petition to the applicant at the address indicated above at the time of filling. The failure of any person to file a petition within this time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, PS, or to intervene in this proceeding and participate as a party to it.
