Introduction:

Ranger Construction is a road building, site work, asphalt paving, and excavation contractor serving the northeast, central and southeast areas of Florida.

Facility was never previously inspected by the Department

Facility was inspected for waste maintenance and management at their truck and equipment maintenance and repair shop.

Facility has been at current location for 20 years, is located on 20 acres, uses city utilities and employs 75 people.

Process Description:

Facility operations result in the following waste streams generated:

- Parts washer waste (mineral spirits) stored in 2 parts washers, indoors; manged by FCC on monthly basis
- Batteries stored inside; exchanged by Royal Battery
- Oily rags stored in designated containers; managed by FCC
- Used oil filters stored in thee (3) 55-gal drums; stored indoors; managed by FCC
- Used oil stored in 1000-gal AST (within secondary containment); stored outside; managed by FCC
