Thank you for contacting the Florida Department of Environmental Protection (DEP). It was a pleasure meeting you at Lakeland City Hall earlier this year.

DEP is aware of the incident that occurred at the Aqua Clean facility. Our Bureau of Emergency Response sent a staff member to the scene yesterday morning. In this particular case the role of DEP's Emergency Response was to look at the environmental and health concerns specifically related to runoff from extinguishing the fire. Based on the onsite inspection conducted by our staff member, the runoff was contained onsite and was being processed through the Aqua Clean facility.

Currently the Fire Department is the lead in this investigation. DEP was there to offer support in our specific area of expertise outlined above. DEP's Bureau of Emergency response will put together a brief summary report of this incident which I can share with you and everyone copied on this email once it is complete.
