Bruce:

Assuming a 3-year permit to coincide with the expiration date for your RCRA permit, the solid permit fees would be as described –  $3/5 \times \$2000 = \$1200$ . As far as continuing to review drafts, I do not have an objection doing that, with the caveat that the next submittal of draft documents include all the information to be submitted with the application, including drawings and information to be submitted for the RCRA permit, that are 100% complete versions of what is proposed to be submitted.
