COMPLAINT RESPONSE

On June 25, 1997 I responded to a complaint regarding alleged hazardous waste dumping by A. R. Paquette.

Mr. Allen Paquette operates a business as an ICC (Interstate Commerce Commission) Carrier and transporter of hazardous & non-hazardous waste. The 1.73 acre facility is located at 1400 International Speedway Boulevard, DeLand, Volusia County, Florida, 32720 and zoned by the County as M-1. At the time of this unannounced site visit, there was no hazardous waste at this facility. A.R. Paquette has been registered with the State as a transporter of hazardous waste since April 1, 1987, their transporter identification number is FLD982105884. At this location, A.R. Paquette does not operate as a transfer facility or permitted hazardous waste storage facility

A second site visit was conducted on June 27, 1997 with the purpose of conducting a hazardous waste compliance inspection. The following are items noted during the inspection.

<u>Maintenance Shop</u> - The maintenance shop is where A. R. Paquette conducts general automotive maintenance and repairs on privately owned trucks and vehicles. Located in the shop were the following items:

- One 16 gallon parts washer on contract and serviced by Safety Kleen
- Two 55-gallon drums of used oil
- One partially filled 55-gallon drum of absorbent material (Oil Dry)



<u>Truck Yard</u> - Located south of the maintenance building, semi-trucks & trailers are stored along the property fence line. This is also an area where empty roll-off bins (20 & 22 cubic yard capacity) are stored.

<u>Shed</u> - Located west of the maintenance building is a covered shed (approximately 1600 sq. ft.) which is leased to Mr. Richard Emch. Mr. Emch is temporarily operating Richard's Towing Company from this location. It is my understanding that Mr. Emch is having a facility constructed which he will operate from in the near future. Inside the shed there was one 16 gallon parts washing machine. When spent, solvent from the parts washer in the shed is combined with the parts washer in the maintenance shop and serviced by Safety Kleen.

## General Information

- A. R. Paquette is a conditionally exempt small quantity generator of hazardous waste.
- Cloth rags are serviced by Unifirst Linnen Services, 1455 Buffalo Road, Titusville, FL 32796.
