Good Morning Jeff,

Attached is your draft permit. The model used for this permit is the same one we used for the recently-issued Orange Park permit, so there should be no changes in the boilerplate conditions. However, it would not be a bad idea to review the entire permit. Mistakes can happen.

There are a few highlighted areas in this draft. One area is on the date for the final permit, and we have not received the latest electronic copy from you that should be in the mail. There is also a condition regarding payment for renewals and mods, and Bryan Baker will let me know where this money should be sent to in the future. Both of these issues are minor, and there is no need to hold up sending this draft to you while we wait.

As before, I'd appreciate comments as quickly as possible. If I do not hear from you in about a week, I will check in but we'll give you a reasonable time to review this. As always, call if you have questions. You can send your comments via e-mail. In the rare event that you might have no comments (it happens with permittees occasionally), let us know that also. We will enter your "no comment" e-mail into the public record. Thank you, Jeff.
